DRIVING DIRECTIONS:

From Sacramento International Airport/Traveling South on I-5: (15 minutes) Take the J Street exit off I-5. J Street is one-way. Follow J Street to the Sheraton Grand at 1230 J Street on the right-hand side. If you pass the Sacramento Convention Center, you have gone too far.

From the Bay Area: Take I-80 to the Capitol City Freeway (Old Business 80) East to I-5 north. Approximately one mile later, take the J Street exit. J Street is one-way. Follow J Street to the Sheraton Grand at 1230 J Street on the right-hand side.

From Reno: Take 80 West toward San Francisco. Take the I-5 South (toward L.A.). Exit at the J Street exit (J Street is one-way). Follow J Street to the Sheraton Grand at 1230 J Street on the right-hand side.

From Highway 99 South (Stockton, Modesto, Fresno, Bakersfield): Take Highway 99 North to the I-80 San Francisco turn-off. Take I-5 North toward the airport and Redding. Take the J Street exit (J Street is one-way). Follow J Street to the Sheraton Grand at 1230 J Street on the right-hand side.

From South Lake Tahoe, Hwy. 50: Take Highway 50 South to the I-5 North toward Redding and the airport. Take the J Street exit (J Street is one-way). Follow J Street to the Sheraton Grand at 1230 J Street on the right-hand side.

PARKING: Self-parking for Sheraton overnight guests is \$18 per day. Turn left off J Street onto 13th Street for entrance into self-parking lot. Valet parking for overnight guests is \$25. Hourly rates also available.
